 Only entries with the accompanying entry fee will be accepted.

Please check so that entries include the correct department, class & item number. Please note only one exhibit per item number per exhibitor is allowed. Jr. Horse Exhibitors: Please list the name or other identification of your horse behind each class entered.

Junior Fair Exhibitors must be enrolled in projects that correspond to each department entered. Enter your exhibits in department, class and item number order.

INSTRUCTIONS FOR FILLING OUT ENTRY FORM

1. Enclose appropriate entry fees. \$2.00 for Junior Fair and \$3.00 for Open Class. This fee is per exhibitor (per person).
2. Fill out all information completely (name, address, grade-Junior Fair only).
3. Please check so that ALL entries include correct department (All Junior Fair depts. Are numbered 1 to 34 while Open Class depts. are numbered 101 to 128. SEE EXAMPLE BELOW).
4. Make yourself a copy or write down your fair entries.
5. All entries are due to the UW-Extension office, La Crosse County Administrative Center by June 4, 2009 or postmarked June 2nd. There is a late entry fee of an additional \$5.00 from June 4 to July 1. NO Changes/Additions will be accepted after July 1.

EXAMPLE: "Jane Doe", a member of the Happy Clover 4-H Club has the following exhibits to take to the fair:

- A Guernsey heifer, summer yearling born on June 8 of the year preceding the exhibit year. **Department 1 Dairy Cattle, Class B Guernsey and Item #4 Heifer, summer yearling.**
- A poster on Animal disease. **Department 10 Animal Science and Small Pets, Class A Veterinary Science 1, Pets 1 Item #5 Poster on care of an animal.**
- A clay bowl, made by hand, using the "pinch" method. **Department 18 Arts and Crafts (Cultural Arts), Class I Other Painting / Drawing, Item #5 Sketch book.**
- A photography exhibit displaying a color photo of a child. **Department #20 Photography, Class A People Photography, Item #1 Child(ren) 18 years and under – Color.**
